## POWERS OF A CHARTERED UNIT



1. To retain its Charter until lawfully surrendered or revoked.
2. To fix its time and place of meeting.
3. To meet and do all the work of the Craft.
4. To elect members, and reject any applications for membership. (Warranted Charters only.)
5. To elect and install it's officers (Warranted Charters only).
6. To make laws requiring its members to contribute to its funds.
7. To instruct its representatives, for their government, of all communications of the Grand Consistory and Supreme Grand Lodge.
8. To place on trial, for cause, its own members, and unaffiliated Sublime Princes living within its own jurisdiction. (Warranted Charters only).
9. To appeal to the Supreme Grand Master and the Supreme Grand Lodge of decision of the Grand Ill. Commander-in-Chief.
10. To make By-Laws for it's local government.
11. To be represented in all communications of Ramesses Grand Consistory #100 (Warranted Charters only).
12. To protection while in the lawful exercise of its inherent rights.
13. To the enjoyment of all powers conferred by the Supreme Grand Lodge upon any Constituent Unit (Warranted Charters only).

*All local Units will hold election the first meeting in December. Their Officers will be installed at this meeting, or the first meeting as soon thereafter as possible.*
